Descriptive Note:	This collection contains personal items and both personal and professional documents/papers of Mr. J.C. Brown (1886-1968). Mr. Brown was an attorney in Madison for 50 years, and was also a North Carolina Senator representing the twenty first Senatorial District in

the North Carolina State Senate from 1923-24. He was very involved in the Madison and greater Rockingham communities. He received his law degree from Wake Forest College in 1913, and later studied at the University of Grenoble, in Grenoble, France. Mr. Brown was a veteran of World War I. He married Eliza Pratt in 1921; she was his only immediate survivor upon his death.
