Descriptive Note: The Improved Order of Red Men traces its origin to certain secret patriotic societies founded before the American Revolution. They were established to promote Liberty and to defy the tyranny of the English Crown. Among the early groups were: The Sons of Liberty, the Sons of St. Tammany, and later the Society of Red Men. Goals of the group are to promote

patriotism and the American Way of Life, to provide social activities for the members, and support various charitable programs.

This collection, recovered from a vacant building in Reidsville, NC, includes organizational and financial records and correspondence of the Comanche Tribe No. 38 and the Wabash Tribe No. 193.
