## # 41 Verification of 2018 IRS Income Tax Return Information for Student Tax Filers

Important Note: The instructions below apply to the student, and spouse if married. Notify the Financial Aid Office if the student or spouse filed separate IRS income tax returns for 2018 or had a change in marital status after December 31, 2018.

Instructions: Complete this section if the student and spouse filed or will file a 2018 IRS income tax return. The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of the 2020-2021 FAFSA. In most cases, no further documentation is needed to verify 2018 income information that was transferred into the student's FAFSA using the IRS DRT.
