#### **DRIVER'S ELIGIBILITY for MINORS:**

- 1. Attend 60 hours of Basic Skills classes per month.
- 2. Demonstrate progress in your studies through standardized testing.

If you violate either of these (1 & 2), your driving privileges will be suspended.

If you do not have a driving license/permit in NC and want to become eligible for one prior to becoming 18 and prior to earning your Diploma, you must:

- 1. Attend 60 hours of Basic Skills classes per month for six months.
- 2. Demonstrate progress in your studies through standardized testing.

When you meet these two criteria, please contact the Basic Skills Director, Jennifer Cox, at 336-342-4261 extension 2305. You will be eligible for the Driver's Eligibility Certificate based upon your initiation of the request. The Basic Skills Director will meet with you and your guardian/parent to complete the Eligibility Certificate,
