2020-2021 Child Care Grant

What is it?

The RCC Child Care Grant is a grant funded by the state of North Carolina to assist currently enrolled students with their child care expenses. It is meant to serve as partial and temporary child care funding while the student is enrolled in classes and is meeting the grant requirements. Funds are paid directly to the state licensed day care centers for children between the ages of birth - 5 years old. After school care is not eligible. The grant is paid based on a daily rate and attendance. The grant covers the fall and spring semesters as long as the student is enrolled and meeting all eligibility requirements.

Am I Eligible?

To be eligible for the grant you must meet the following requirements:

- Must have satisfactory SAP status
- Must be currently enrolled in a degree or Title IV eligible program
- Must be enrolled at least 6 credit hours
- Must have completed one semester at Rockingham Community College
- Must be a NC resident
- Must be the legal guardian or parent of the child

How Do I Apply?

To apply for the NC Child Care Grant a student must complete the following:

- RCC Child Care Grant Application
- Free Application for Federal Student Aid (FAFSA) with RCC
- FAFSA verification process (if selected)
- Admissions Process for a curriculum program at RCC
- Submit documentation for any other source of childcare assistance

Incomplete applications will not be considered.
