

Report on HEERF II / CRRSAA and HEERF III / ARP Funding for Student Relief Received by Rockingham Community College

Date of Report: September 30, 2021

In compliance with requirements of the CRRSAA and ARP (a)(1) and (a)(4) programs, Rockingham Community College submits the following report:

1. Acknowledgement

Rockingham Community College acknowledges that it signed and returned to the U.S. Department of Education the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

2. Amount of Funds Received

Rockingham Community College has received \$2,195,785.00 (HEERF II \$466,857 + HEERF III \$1,728,928) from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

3. Total amount of Emergency Financial Aid Grants distributed to students

For the quarter ending September 30, 2021, the amount of Emergency Financial Aid Grants which Rockingham Community College has distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs is \$1,061,496.62 (Direct Payment Grant \$6,570.00 + Remaining Balance Grant \$4,813.00 + Debt Repayment/Tuition & Fees Payments with Permission received by students \$1,050,113.62).

Since the start of these programs, the cumulative totals distributed are \$1,229,286.45 (Direct Payment Grant \$39,850.00 + Remaining Balance Grant \$56,950.00 + Debt Repayment/Tuition & Fees [Permission received by student] \$1,132,486.45).

4. Estimated Number of Eligible Students

Rockingham Community College estimates that the total number of RCC students eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs is **1248**.

5. Number of Students Receiving Grants

For the quarter ending September 30, 2021, **833** unduplicated Rockingham Community College students have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

6. Method(s) Used to Determine Which Students Received Grants and Amounts

Rockingham Community College used the following method(s) to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs:

RCC senior administrators and enrollment and financial aid directors met on March 26, 2021 to determine which students would receive grants and the amounts given. The group reviewed guidelines from the Department of Education and determined that funds would be disbursed to curriculum students; however, a FAFSA application would not be required. It was also determined that Pell eligible students would be prioritized. Students were required to submit a short application to indicate how they were impacted by COVID. The following funding scenario was developed:

RCC chose to use an enrollment intensity model using credit hour ranges of 1-4, 5-7, 8-11, and 12+ hours. A minimum distribution amount of \$150 to cover the tuition for at least one 3-hour course was established, with a maximum award amount of \$750 for those taking 12 or more hours. Students who are Pell-eligible received an additional \$100.

RCC chose to modify the model for the 2021-2022 academic year. Students enrolled in less than 6 credit hours or less received \$600, and students enrolled in 7 credit hours or more received \$1200.

7. Instructions to Students

Rockingham Community College provided the following instructions, directions, and guidance to students concerning the Emergency Financial Aid Grants:

On April 13, 2021, RCC's Financial Aid Office began sending multiple e-mails (see below for full text) and an electronic flyer (see below) to Summer 2021 registered students, informing them of the availability of funds. No deadline was established.

The college's Public Information Office took the following actions:

A yellow announcement bar was placed across every page on the RCC website and the online student information portal, Self-Service, announcing the deadline to apply and containing a link to the application. On April 30, 2020, a news story was posted on the website, **Students: Apply for emergency relief funds by May 11**, with a follow-up story on May 12, **\$150k in Emergency Relief Funds awarded to students; \$350k still available**. Both stories were distributed to local media outlets. They were also shared on RCC's Facebook, Twitter and Instagram pages. Links to the stories were also posted on the RCC Cares page, which contains COVID-19 information and updates. Invitations to apply for the funds have been posted across social media on several occasions.

Attention all Summer 2021 students!

The U.S. Department of Education is providing federal funding for students due to COVID-19 through the CRRSA Act (Coronavirus Response and Relief Supplemental Appropriations Act) HEERF II (Higher Education Emergency Relief Fund). Students who have registered for Summer 2021 must complete the application to apply. Funding is limited and applications should be submitted through June 11th.

Eligibility Criteria

- *Enrolled in a curriculum program at RCC for Summer 2021*
- *Have a High school Diploma or GED Equivalent **(CCP - Career & College Promise and ECHS - Early College High School students are not eligible)***
- *Meeting RCC Satisfactory Academic Progress Requirements*

FAQs:

How do I apply for Emergency Relief Fund?

- Complete the [HEERF II Application \(Higher Education Emergency Relief Fund\)](#)

Do I have to submit the FAFSA to be eligible?

- *No. However, students with demonstrated need as determined by the FAFSA will receive a greater amount of funding.*

I have not submitted a FAFSA application, is it too late?

- *No – You can submit your FAFSA now. However, the FAFSA must be submitted and received by RCC prior to student's completion of this HEERF II application to be considered for the greater amount of funding.*

How much funding can I receive?

- *Grant amounts vary by student circumstances.*

How will I receive my funding?

- *Direct deposit (enter banking information via your self-service account) or paper check to the mailing address on file if no bank account information is entered.*

How can the funding be used?

- *Funds should be used for emergency expenses incurred due to COVID-19.*

How will I know if I have been approved?

- *You will be notified via your RCC email account.*

Can I receive an additional award if I have previously been awarded in prior semesters?

- *Yes!*


