EMT-INITIAL APPLICATION PROCESS

- STEP 1:** Complete the [NC Residency \(RDS\) and RCC application](#) on the college website.
- STEP 2:** [Schedule an appointment](#) to talk with an admissions counselor to discuss the EMT-Initial program requirements, English placement, and the application process.
- STEP 3:** Send your official high school or GED transcript to the Admissions Office. Official transcripts can be emailed to transcripts@rockinghamcc.edu.
- STEP 4:** After your appointment with RCC Admissions, you will receive EMT-Initial Candidate Review Form. Submit the online form and required documentation. You will receive an email confirmation once your application has been received and is under review.

All items are required in order to apply for the program.

- Official high school or GED transcript on file with the Admissions Office
- English placement test scores or waiver on file (credit for DRE 097, RISE English Tier 1, or placement test scores)
- Copy of government-issued photo ID (i.e., driver's license, passport)
- Affiliation Letter (*if affiliated with NC Fire/Rescue/EMS agency*)
- Payment receipt for background check from Viewpoint Screening (Order Confirmation Page) - [*Viewpoint Screening Instructions](#)

***PLEASE NOTE: EXEMPT FROM VIEWPOINT SCREENING IF AFFILIATED WITH AN AGENCY.**

- STEP 5:** You will receive an email notification when your application has been approved. Admitted students will be contacted by the EMS Program Director and registered for the class. Payment is due by the posted deadline.

EMT-INITIAL COURSE DESCRIPTION

The EMT program is designed to teach basic life support skills. EMTs are able to function in many areas including EMS systems, fire departments, hospitals, rescue squads, and physician offices. The class consists of lectures and hands-on skills instruction as well as field clinical opportunities. Upon successful completion of this course, students will be eligible to sit for the North Carolina or National Registry EMT examination.
